

Return of fans and aerial engineering components

General information!

We as an enterprise have the responsibility for the health and security of our workers. Therefore the operator has to indicate us whether the returned parts have been contaminated with pollutants or dangerous materials, so that we are able to protect our workers who come into contact with the fans and aerial engineering components during the damage analysis, repair or maintenance.

Please complete page 2 and 3 “**Declaration of the operator...**”.

- If your return already reached us without advance notice, please send us this declaration back, immediately after having received it, because we do not have a protected stock pile for construction units which are possibly afflicted with pollutants available. If your declaration should not be present immediatly, we will have to consider the unfree return to you. We are asking for your understanding! Please be aware of this!
- If you announce us your return, you can receive this form in advance or you can download it from our homepage.
Please attach a second copy to the accompanying documents of the transmission.

If a stronger contamination with hazardous substances or heavy pollution should be present, the equipment must environmental fairly and technically cleaned in advance before delivery to HLU.

Please note that we cannot accept and repair fans or components contaminated with residues of hazardous substances!

Only these fans and components can be examined, repaired or waited by our workers, which are free from pollutants or which can be handled with protection gloves or eye protectors!
